The process was collaborative and thorough, designed to ensure the final selection honors both the fire department’s history and public safety. Final recommendations will be compiled and submitted before moving forward with artist contracting and installation.

The selection process prioritized durability, safety, originality, material suitability, and adherence to a set budget. After discussing the pros and cons of various materials and designs, the committee highlighted the need to balance artistic intent with practical, weather-resistant, and maintenance-friendly choices. Final recommendations will be compiled and submitted before moving forward with artist contracting and installation.
